



## BUSINESS SPONSORSHIPS

Funds donated by business sponsors will go toward the capital replacement fund. There are various levels of sponsorship as indicated in the table below. Benefits of business sponsorships are also listed.

For the 2024-2029 campaign, we are offering business sponsors (or even individuals) the opportunity to "sponsor" various parts of the RFCC complex for the upcoming 5-year period. The list below delineates the suggested support levels associated with various parts of the RFCC complex. Payments can be made in one lump sum or spread over the 5-year period to fit your needs:
